In addition, clients can withdraw any portion or all of their account balance at any time without penalty. There are no entrance fees and, once your account is funded, there are no maturity dates or exit fees.

Security

All managed funds are held in segregated accounts and deposited in our tier-1 affiliate international banks such as HSBC and Emirates NBD, among others. Clients are the owners of their respective accounts, which are only linked to Vernier Capital Advisors account for trading purposes.

Basis Of Trading Strategy

Vernier Capital Advisors managers look to achieve 25 Pips on the upside, with a 15 Pip stoploss in place. What this means is that, assuming 1 trade a day, our clients recognize gains even if 3 out of 5 trading days are losses. The other 2 days out of 5 will still place the client in a profitable position for the week. To illustrate this concept in simple terms:

Gains: 2 days x +25 Pips = +50 Pips
Losses: 3 days x -15 Pips = -45 Pips
Weekly Net: Gain of 5 Pips



Trade Example

Buy 1 EUR/USD
For 1.1737

Close 1 EUR/USD
For 1.1762



Our Fees

Vernier Capital Advisors offers managed accounts with no entrances fees, maturity fees or exit fees.

Our services are commission based. We only make money if our clients make money.

Vernier Capital Advisors charges a commission of 25% based on the high water mark (HWM) principal. Fees are only paid on net new rises in values. If a client's portfolio suffers a temporary decline, no fees are charged until the gains are recovered. This principal ensures that fees are paid only when a client's account recognizes gains on a monthly basis.

FAQS

How do I access my account?

Once your account is actively trading, you may log in to the Vernier Capital Advisors trader platform via our website to monitor your account activity and performance 24/7 from your computer or mobile device.

How is my investment protected against provider failure?

Vernier Capital Advisors holds each client's capital in a segregated bank account with one of our tier-1 international banking affiliates, which will ensure that your assets are protected at all times.

How often will my account be traded?

With an eye toward minimizing risk and optimizing gain, Vernier Capital Advisors managers isolate the most profitable trade for each client's portfolio on a daily basis, depending on each client's indicated level of risk tolerance.

Can I invest more capital after my initial deposit?

Yes. After the initial investment, a client may add funds at any time, with a minimum additional investment of €1000. This can be arranged through your dedicated account manager.

How can I make a withdrawal?

You can withdraw any portion or all of your account balance at any time without penalty by completing and submitting a simple withdrawal form. Your funds will be provided within the bank standard maximum of 5 business days.

How will my account be taxed?
